Juvenile Curfew Citations




- Curfew Ordinance Violations issued by LPD from January 1, 2019 through June 30, 2022:
 - 200 total violations
 - 191 issued to juveniles
 - 9 issued to adults
- Nighttime vs Daytime Curfew Violations
 - 161 nighttime curfew violations
 - 39 daytime curfew violations

*note: Agenda comments showed 198 citations. Two citations had two violations each bringing the total to 200.

The chart below depicts a count of Juveniles (ages 16 or younger) *arrested* during nighttime curfew hours for Thursdays (11:pm – 6:am), Fridays, and Saturdays (12:am – 6:am), broken down by each year. **254** *arrests* occurred during this period.






Juvenile Curfew Enforcement Plan




- Directed enforcement Thursday through Saturday, midnight through 6:00 am
- Staffing
 - Four officers working in teams of two looking for curfew violations
 - Two officers assigned to the Curfew Center
- Curfew Center
 - East Patrol Division Station Community Room
 - Meets the criteria set forth in the ordinance
 - Centrally located
- Procedures
 - Officers will bring violators to the Curfew Center and write the juveniles citations
 - Officers staffing the Curfew Center will contact a parent or guardian
 - When the parent or guardian arrives to pick up the juvenile, they will also be issued a citation




Juvenile Arrests During Curfew by Month & Year






Average of Juvenile Arrests During Curfew Hours between Jan 2019 & June 30, 2022
