



**Parks and Recreation
Inflatable Play Equipment Permit**

1. This permit is non transferrable and is subject to revocation by the Director of Parks and Recreation.
2. This permit shall be made available upon request.
3. Applicable federal, state and local laws, ordinances, statutes and rules shall be observed.
4. Inflatables are permitted only at the following parks: Mackenzie, McAlister, Aztlan, Buddy Holly Recreational Area, Clapp, Elmore, Fiesta Plaza, Higginbotham, Leftwich, Mae Simmons, Mahon, Maxey, McCullough, Miller, Ribble, Rodgers, Stubbs, Woods, Huffman Athletic Complex, Lubbock Youth Sports Complex and Guadalupe.
5. Equipment shall be placed in a manner ensuring the safety of users.
6. There shall not be more than one inflatable in Guadalupe park and any inflatable shall not operate for more than 6 hours at a time.
7. A representative from the inflatable company must be on site with the inflatable during operation.
8. Inflatable may not be set up:
 - a. within 100 feet of private property
 - b. within 50 feet of any park playground, amenities or body of water
 - c. within 20 feet of any public building, restroom, street, right of way or parking area
 - d. on any trail or facility such as a tennis court, basketball court, shelter or pavilion.
9. Electricity, if available, may be rented from Parks and Recreation for use with inflatable at least 2 business days before event.
10. Inflatables may use electrical generator. Generator must comply with all regulations including but not limited to fire code regulations and local ordinance. Generator can only be set up in parking areas, not on turf. Only factory installed fuel tank is permitted.
11. Inflatable equipment must be hand carried onto park property. Motor vehicles are strictly prohibited on grass.
12. Water inflatables are not allowed on park property.
13. Sand bags or stakes may be used to secure equipment but in order to prevent damage to irrigation system, please provide a map with precise location of inflatable.
14. Indemnity: Lessee, to the fullest extent permitted by law, shall indemnify, defend and hold City, its officers, agents, employees and elected officials free and harmless from and against any and all claims, losses and/or liabilities which arise directly or indirectly, or are related to, in any way, manner or form, the activities contemplated by the Lease and/or the Lessee's agents, employees, invitees, patrons, licensees, guests and/or independent contractors use and possession of the persons, including Lessee, in or about the premises. Such indemnification includes but is not limited to liability resulting from the unintentional interruption of utility services.
