If everyone who signed up to speak has been given an opportunity to speak and the thirty minutes designated for public comment has not been exhausted, the Electric Utility Board may, at its discretion, open the floor to anyone else wishing to address the Electric Utility Board, subject to all the same procedures and guidelines.

- Goals for outages and response times as part of the planning process;
- Other opportunities to increase LP&L's value; and
- Next steps related to Strategic Planning.
