History of Brick Streets in Lubbock




- Pre-1920 Dirt streets maintained with water for dust control
- 1920 The City of Lubbock's first bond for the paving of City Streets with vitrified brick from the Thurber Brick Company



History of Brick Streets in Lubbock



1920 to 1930 — Construction of most brick streets that exist today



History of Brick Streets in Lubbock



- 1930 All future paving was constructed in asphalt
- 1982 Resolution No. 1024 adopted a policy of continued protection of all of the City's brick streets
- 1982 City purchased approximately 345,000 used brick pavers from the Cities of Plainview and Crosbyton for use on Broadway

RESOLUTION

A RESOLUTION ADOPTING THE CONTINUED PROTECTION OF BRICK PAVERS ON LUBBOCK

WHEREAS, the City Commission authorized Lubbock's first brick street paving in 1920; and

WHEREAS, the first portions of streets to be paved included the area around the Lubbock County Courthouse; and

WHEREAS, these brick paving projects were continued throughout the 1920's and 1930's, and include many miles of brick streets; and

WHEREAS, many of Lubbock's brick streets are paved with red brick manufactured by the Thurber Brick Company, Thurber, Texas, which is no longer available; and

WHEREAS, brick streets are a part of the heritage of Lubbock; and WHEREAS, preservation of this heritage will benefit existing and

future generations of Lubbock citizens; and

WHEREAS, brick streets provide a continuing useful and low maintenance paving material; and

WHEREAS, numerous utility repairs and installations, street repair, and re-surfacing of intersecting streets have left Lubbock's brick streets a patchwork of brick, asphalt, and concrete; and

WHEREAS, the Urban Design and Historic Preservation Commission and the Planning and Zoning Commission for the City of Lubbock have resolved that the preservation and restoration of brick streets is a continuing source of community pride;

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LUBBOCK:

THAT any portion of any brick street surface disturbed by any public or private agency for whatever reason be replaced in a manner consistent

Adopted City Ordinances/Policies



- 2006 Ordinance No. 2006-00069 adopted in response to numerous utility repairs, installations, street repairs, and resurfacing projects that had left a patchwork of brick, asphalt, and concrete.
- 2008 Adopted the Lubbock Downtown Revitalization Plan which included a recommendation to maintain and/or extend brick paving on: Broadway, Avenue J, Buddy Holly, & Crickets
- 2012 Downtown Public Improvements Design Standards which reiterated the protection of brick streets and encouraged the use of stored historic brick for projects before using new or non-historic brick
- 2018 Updated the Downtown Public Improvements Design Standards
 - Amended what types of projects trigger the public improvement requirements, the approval process, and updated the boundary
- 2020 New Downtown Master Plan adopted by the Lubbock City Council to include recommendations pertaining to brick streets

AN ORDINANCE AMENDING CHAPTERS 36 AND 40 OF THE CODE OF ORDINANCES OF THE CITY OF LUBBOCK, TEXAS, BY REPEALING SECTIONS 36 07.011 AND 36.08.006 IN THEIR ENTIREFTY, AND AMENDING SECTION 40.03.3221 "PUBLIC IMPROVEMENTS" REGARDING BRICK STREETS AND ALLEYS, PROVIDING A SAVINGS CLAUSE; PROVIDING A PENALTY CLAUSE; AND PROVIDING FOR PUBLICATION.

WHEREAS, at the January 28, 2020 work session of the City Council of the City of Lubbock, the City Council heard a presentation by Overland Partners, Inc. ("Overland") regarding the Downtown Master Plan Update (the "Plan"); and

WHEREAS, as a part of the Plan, Overland made specific recommendations to the City Council regarding brick streets and alleys in Downtown Lubbock; and

WHEREAS, the City considers Overland's recommendation for brick streets an important resolution to the maintenance of brick streets and alleys; and

WHEREAS, on July 9, 2020 the City Council adopted the Plan via Resolution No. 2020-R0187; NOW THEREFORE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LUBBOCK:

SECTION 1. THAT Sections 36.07.011 and 36.08.006 are repealed in their entirety, and the remainder of the Articles within which they are located, shall be remumbered accordingly.

SECTION 2. THAT Section 40.03.3221(b) of the Code of Ordinances of the City of Lubbock, Texas, is amended to read as follows:

Sec. 40.03.3221 Public improvements

(b) <u>Brick streets and alleys</u>.

(1) <u>Protection</u>. In keeping with the policies outlined in Section 40.03.3213 of the City of Lubbock Code of ordinances. historic brick streets are hereby prioritized with certain protections through preservation and provisions for alteration or removal.

(A) Any portion of Braadway Avenue (between University Avenue to Avenue E) disturbed by any public or private agency for any reason must be replaced in a manner consistent with a design adopted by the City Council retaining the historic brick wherever brick is included in the adopted design; CUY Council shall seek input from the UDHPC, the CBD TIF Board, the City Manager, and the public prior to adopting a design.

- (B) Any portion of the following brick streets disturbed by any public or private agency for any reason shall be replaced in a manner consistent with one or more designs adopted by the City Council which shall respect the original brick aesthetics of the following streets:
 - Crickets Avenue (between 17th Street and Broadway Avenue);
 - Buddy Holly Boulevard (between 16th Street and 8th Street);
 - (iii) Texas Avenue (between 19th Street and 7th Street); and
 - (iv) Avenue J (bet ween 16th Steet and 9th Street).
- (C) Any portion of the brick streets disturbed by any public or private agency for any reason within the following areas must be replaced in a manner consistent with the original brick construction:
 - The South Overton Residential Historic District, and in keeping with the Historic District requirements as set forth in Ordinance 2011-00072;
 - (ii) 20th Street (between Boston Avenue and Avenue X); and
 - (iii) Main Street (between University Ave and Ave Q).
- (D) All other brick streets disturbed for any reason, other than utility repairs, may be replaced by asphalt, concrete or brick in a manner consistent with Article 3604 of this Code of Ordinances upon review and approval by the City Manager. In making his/her determination, the City Manager shall consult with the UDHPC, and shall consider the following:
 - Adjacent to historic or potentially historic buildings;
 - (ii) Majority of the brick surface intact;
 - (iii) Importance to community history;
 - (iv) Importance to downtown redevelopment efforts; and

(v) Structural condition/indications for long-term stability


- (2) <u>Review</u>. Review and approval of requests for removal or reconstruction should be conducted prior to project bid, and must be completed before removed or reconstruction can begin. Any contractor or department wishing to remove or alter a brick street surface must submit complete plans to the City Manager, or designee, for approval.
- (3) <u>Appeal</u>. Any applicant or interested person aggrieved by a ruling of the City Manager shall appeal to the City Council of the City of Lubbock within thirty (30) days of the City Manager's decision.
- (4) <u>City Property</u>. Any bricks removed from any street or alley, whether through repair, reconstruction or removal, are the property of the City of Lubbock and must be returned to the Streets Department.
- (5) <u>Repair</u>. Any utility cuts or other disturbances to brick street surfaces must be repaired in a manner consistent with current construction of the street as outlined in Sections 36.05.002 through 36.05.004 of this Code of Ordinances.
- (6) <u>Exceptions</u>. The following bricks are not subject to the requirements of this section other than subsection (4) above:
 - (A) Any portion of a brick street intersection disturbed and/or removed for construction of new crosswalks in compliance with the Americans with Disabilities Act (ADA);
 - (B) Construction related to stormwater drainage valley gutters; or
 - (C) Existing brick alleys, which may be replaced by asphalt, concrete or brick in a manner consistent with Article 36.04 of this Code of Ordinances upon review and approval by the City Manager.

SECTION 3. THAT a violation of any provision of this Ordinance shall be deemed a misdemeanor punishable in accordance with state law and Section 1.0.004 of the Code of Ordinances of the City of Lubbock.

SECTION 4. THAT should any paragraph, sentence, clause, phrase or work of this Ordinance be declared unconstitutional or invalid for any reason, the remainder of this Ordinance shall not be affected thereby.

SECTION 5. THAT the City Secretary is hereby authorized to cause publication of the descriptive caption of this Ordinance as an alternative method provided by law.

CBD TIF Recommendations



- A design firm should be hired to provide a complete design for the street.
- Underground utilities should be considered at the same time as street repair.
- The design should provide a balance between what is historical and what is practical.
- The CBD TIF Board's preference would be that brick be used in key intersections only, not in the drive lanes, for the following reasons:
 - Cost of material and installation
 - Does not require tearing up other streets to gather material
 - Drive lanes and bike/walking lanes will be smoother and easier to repair
 - We believe this will have citizen buy-in because it honors the history of the street without overspending, and it allows for more reasonable maintenance
 - Historic brick should not be added to Broadway eastbound beginning at Ave E.
 - Historic brick should not be added into sidewalks, or back of curb.
 - Historic brick should not be used in bike lanes and crosswalks.
 - Historic brick should be incorporated into the street design.

UDHPC Recommendations




- Don't use Thurber brick where it wasn't originally located.
 - Don't use east of Ave E
 - Don't use on sidewalks.
- Use Thurber brick as much as possible on the entire width of the street (i.e. curb to curb) to retain the historic image/sense of place of Broadway
 - As a minimum use the Thurber brick on all drive/turn lanes
 - Create a design that emphasizes/reinforces the image of historic red brick from curb to curb. With a goal to minimize the use of other colors/materials across the width of the street.



- If Thurber brick can't be used everywhere then prioritize its use:
 - Highest priority: use the Thurber brick on all drive/turn lanes.
 - Lesser acceptable priorities to consider if Thurber bricks quantity is a concern or for significant engineering reasons:
 - Consider a series of center medians west of Ave Q, since it had that initially. This could also slow traffic down.
 - Intersections: Consider using new brick pavers in the intersections much like what was done at City Hall.
 - Redefine "curb to curb" by moving where the curb is.
 - Lubbock Heritage Society (LHS) Option #2: Separates bike lane from drive lanes with a raised curb, this bike pavement area could be typical concrete
 - LHS Option #3: Puts bike lane on same plane as sidewalk
 - Parallel parking/flex zone area (and bike lane if not physically separated):
 - new brick pavers of similar color. Use of brick here would mean that "patching" would not be noticeable.
 - red colored concrete with frequent joint sections and require replacement of an entire section when patched.
- Lastly, encourage the coordinated replacement of utilities to be done when the street is being repaved to minimize "patching of new street" (regardless of what paving material is being used).








BROADWAY OPTION 2 PROPOSED SECTION
